### GIFT SPOTLIGHT Legacy charitable remainder trusts: a gift that lets you "give it twice"

#### What's better than giving a gift once? Being able to give it twice, of course!

Legacy charitable remainder trusts have become a popular way for donors to provide for their children *and* ministry—allowing them to "give it twice."

#### THE BENEFITS

**Flexibility:** Because the trust is funded after the Lord calls you home, you maintain control of your assets throughout your lifetime.


**Provides for your heirs:** Instead of leaving a one-time lump sum inheritance, you can provide an ongoing source of income for your heirs for up to 20 years.

**Tax savings:** Funding the legacy trust from a tax-deferred retirement account may provide additional tax benefits. Rather than having to distribute an inherited IRA within 10 years, the IRA can be used via beneficiary designation to fund a legacy charitable remainder trust with a 20-year payout period.

**A gift to ministry:** At the end of the payout period, the trust remainder is distributed to the ministry (or ministries) of your choosing.



### Helpful tools to support you in giving

#### Letters of instruction

Letters of instruction make it easy to benefit the ministries of your choice.

#### YOU:

- List "WELS Foundation" as your charitable beneficiary.
- Can change your letter of instruction at any time, with no cost to you. Your WELS Christian giving counselor can help.

#### WELS FOUNDATION:

 Provides a letter of instruction to allocate a percentage of your gift to each of the WELS ministries of your choice.

#### **Stock gifts**

Donating appreciated securities like stocks to WELS Foundation provides great tax benefits.

#### YOU:

- Avoid paying capital gains tax.
- Enjoy the ease of having WELS Foundation handle the transaction.

#### WELS FOUNDATION:

- Can sell the stock without having to pay capital gains tax.
- Will give the proceeds to the ministry of your choice.

## IRA charitable distributions

If you are 70.5 and older, you can support WELS ministries through your individual retirement account (IRA).

#### YOU:

- Give up to \$100,000 directly to WELS ministries from your IRA.
- Won't pay income tax on your gift.

#### WELS FOUNDATION:

- Can distribute the money to the WELS ministries of your choice, if you choose to direct your IRA distribution to WELS Foundation.
- Will give you the proper gift acknowledgment for income tax purposes.



# **Charitable gift annuities:** a gift that pays income for life

**Did you know that there are charitable giving plans that will pay you supplemental retirement income for life?** These charitable gift annuity plans are not new. In fact, they have been around since 1831. In addition to quarterly income payments for life, you can receive significant tax benefits from your charitable gift. Then when the Lord calls you home, the remainder of your gift will be distributed to the ministry or ministries of your choosing.

Did you know that you can provide for yourself and your family while reducing taxes and supporting the ministries that you love? Charitable remainder trusts provide income to you for life and/or your children for up to 20 years, with the remainder going to support the ministries of your choice after you are in heaven.

Did you know there is an efficient and flexible way to establish an ongoing charitable legacy? Through a donor-advised fund, you can give a gift now, and recommend the ministries that benefit later. Your gift can also be divided among the ministries you care about, and you'll receive a single receipt for income tax purposes. In addition, you can involve family members in the joy of recommending the ministries that benefit from your gift.

As of June 30, 2023, WELS Foundation administered 83 donor-advised funds.
