

SPOTLIGHT: Charitable Remainder Trusts

Below is an explanation of charitable remainder trusts that your donors may find helpful. <u>Download a PDF of this information</u>.

How does a **charitable remainder trust** work?

- 1 You transfer cash, securities, or real estate into a charitable trust.
- 2 The trust provides income payments for life to you and/or the people you care about (like your children). In addition, you receive a charitable income tax deduction.
- 3 When the trust ends, the remainder will go to support the ministry or ministries that are important to you.



Is a charitable remainder trust right for you?

- You have at least \$200,000 of cash, securities, or real estate that can fund the trust.
- You wish to receive income payments for life (for you and/or your children).
- You would like to benefit from potential income tax and capital gains tax benefits.
- You wish to leave a legacy to support ministry after you are called home to heaven.

You won't get in trouble. We promise.

Charitable remainder trusts are a great giving option for a very specific type of donor, based on the gift amount needed to fund the trust. But the blessings to them and to ministry are tremendous! If you are looking for brief language to promote charitable remainder trusts to your donors, here is wording you can steal and customize:

CHARITABLE REMAINDER TRUSTS: A tax-wise way of providing for children and church

Did you know that you can provide for yourself and your family while reducing taxes and supporting the ministries that you love? Charitable remainder trusts provide income to you for life and/or your children for up to 20 years, with the remainder going to support the ministries of your choice after you are in heaven.



For the second year in a row, the WELS Endowment Fund's net investment return placed in the




The investment returns for the WELS Endowment Fund were 22.39% and 21.22% in 2019 and 2020, respectively.
